

The Mighty Mouth “Floss Dance Giveaway” Contest Official Rules

ELIGIBILITY:

No purchase necessary. A purchase will not increase the chances of winning. Must be 18 or older and must be a resident of Washington State. Open to individual, legal residents of WA who are 18 years of age or older. Employees of Arcora Foundation (“Sponsor”) and members of their immediate family (spouse and parents, siblings and children of their spouse) and persons living in the same household of such individuals are not eligible to participate or win a prize. Void outside WA and where prohibited. One Facebook profile per entry.

HOW TO ENTER:

To enter the **“Floss Dance Giveaway”** contest, participants must post a video of themselves, their children, friends, or family members doing the floss dance and use the hashtag #FlossForKids in the contents of the post to enter. Entrants are encouraged to tag the Mighty Mouth Facebook page (@TheMightyMouth) and the Smile Spokane Facebook page (@SmileSpokane) to show participation in the giveaway. Tagging both Facebook pages is not required to be eligible to win. Posting the video and using the hashtag #FlossForKids is necessary to be eligible to win. Participants may enter up to one time during the month of February, until 11:59 a.m. Pacific time on February 28th, 2019. Sponsor not responsible for late, lost, damaged, illegible, incomplete, and incorrect or misdirected entries. Participants are encouraged to participate in groups with family, friends, and other relatives.

PRIZES:

The “Floss Dance Giveaway” promotion will begin Friday, February 1st, 2019, and conclude Thursday, February 28, 2019, at 11:59 a.m. PT. The twelve prizes valued at \$100 (twelve \$100 Amazon gift cards) will be given away to randomly selected entrants. Three winners will be selected randomly and contacted by the Arcora Foundation on every Thursday during the month of February, on February 7th, February 14th, February 21st, and February 28th, 2019. Entries will be collected by manually collecting names from Facebook posts that include the floss dance video and the hashtag #FlossForKids, and then sorted through a randomization formula to select the winner at random. Odds of winning will vary by the number of eligible entries received. Winners must respond within 48 hours with their phone number and address for the prize to be claimed or a new winner will be drawn. One entry per Facebook profile. The participant uploading the video is considered the entrant and will be the recipient of the prize if selected in the random drawing.

GENERAL CONDITIONS:

No cash redemption, substitution or transfer of prize permitted. All federal, state and local taxes on prize and expenses relating to acceptance and use of prize are the sole responsibility of winner. Prizewinners will be notified by a private Facebook message and will be required to sign and return an affidavit of eligibility and liability/publicity release (except where prohibited by law).
